AGREEMENT TO PARTICIPATE / RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT

I, the undersigned, for the duration of the event, agree to the following:

- Always wear gloves, protective clothing, and appropriate shoes
- Be careful when handling broken glass, sharp objects, aerosol cans, gas containers, etc.
- Do not disturb any drum containers – report their location to the coordinators
- Do not pick up or touch any needles, or drug paraphernalia – report their location to the coordinator
- Watch for snakes, wasps, hornets and poison ivy in debris piles or vegetated areas
- Use common sense about lifting heavy objects
- Never work alone
- Report any accidents or injuries to the coordinator immediately
- Ask permission if entering private property, identifying yourself as a Clean Sweep Volunteer
- Practice social distancing

Risk & Release Waiver

I recognize there are certain risks of injury as a result of my (or my child's) participation in this volunteer activity.
